The next day the family went to see him and but was directed to Detective Branch of the police where they directed the family again to the police station. They are still unable to find out any whereabouts of him. After 3 days, Juwel returned and was with local ward councillor Johurul Alam. Belal's wife Kaniz Fatema confirmed that on 30.01.2021, 03.00am a phone call came through from Belal's number and Belal said on the phone that the abductors left him in the street. Belal was previously working with Chittagong CC Councillor candidate Johurul Alam Josim. The following day, Sabbir's father, Shahab Mia, filed a missing person's diary with the city's Chandgaon police station. On 14 March, Sabbir's family found out from the investigating officer on the case that Sabbir had been picked up by the Detective Branch of police and taken to Dhaka. Sabbir's case is not an exception. On the night of 11 March, four youths reportedly went missing from Chattogram city. They are Imtiaz Hossain Sabbir, 24, Fahad bin Newaz, 26, Borhan, 40, and Masud Hossain, 36. On 12 March, three separate missing diaries were filed with Panchlaish and Chandgaon police stations in the city. For each case, investigating officers commenced investigations and collected CCTV footage of possible sites of disappearances. On 14 March, parties concerned were informed that the four individuals had been arrested in a case filed under the Digital Security Act with the Paltan police station in the capital. The case documents state that the youths were arrested from RS Road near Reyazuddin Bazar of Kotwali police station in Chattogram on 13 March at 9pm. The following day, they were handed over to the court. They are currently in jail . But the families of the victims claim that the four men were arrested in the early night of 11 March from different areas. And 48 hours lapsed before the families were even informed about the arrests.
