Contacted, the landlord Shah Alam Talukdar said, "They came and identified themselves as DB police. One of them showed me a gun and an identity card, which had DB written on it." Mitu said the men were in plain clothes. "But they all wore boots.When they were taking him away, I tried to follow them, but they asked me to go back inside the house.
